## EXPLANATORY NOTES

### Who can use this form to apply for superannuation information?

- A member of SA Police Super referred to as the Member Spouse for Family Law purposes;
- A legal or defacto spouse of a member of SA Police Super referred to as the Non-Member Spouse; or
- A person who intends entering into a superannuation agreement with a member of SA Police Super. That is a person who may be intending to marry the member and is negotiating a pre-nuptial agreement.
- If you ARE NOT a member of Police Super you must provide a copy of two of the following documents:
  a marriage certificate (compulsory);
  - a driver's licence; a government concession card; recent bank account statement; or current utility account e.g. gas, electricity, phone.

## What is a superannuation interest?

A superannuation interest is simply the member's benefit entitlement in a superannuation scheme. SA Police Super is a public-sector exempt, untaxed, defined benefit superannuation fund within the meaning of the *Police Superannuation Act* 1990.

#### What you will receive from your application

On receipt of a valid application form, SA Police Super will provide in writing to the applicant's preferred address, the information as specified by the relevant legislation relating to Family Law. Allow five (5) working days for your request to be provided.

#### Is there a fee?

At this time there are no fees charged for the provision of superannuation information.

#### How to complete this form

- You must tick the relevant options that are applicable and clearly print the details required on the application.
- You must complete all sections of the form (i.e. Section 1-6). Members of SA Police Super do not need to complete Section 5.
- SA Police Super will accept the original of this form by email to <u>admin@policesuper.sa.gov.au</u>.
- The form may be hand-delivered or mailed to SA Police Super at Level 1 South, Hindmarsh Square, ADELAIDE SA 5000 (enter Super SA's front shop on Pulteney Street, and ring the SA Police Super 'door-bell' to alert staff).
